2. To submit at least one logo file and/or photographs of one of your products to be used in promotional activities for Art Sunday. Email promotional items to 3artsclub@gmail.com
3. To maintain a clean, sanitary and family-appropriate area and to behave in a manner appropriate for a family event.
4. Food trucks/vendors are independent contractors and not an employee of the event or affiliated with the Scottsboro Three Arts Club.
5. To carry all necessary insurance covering liability and property displayed at the festival.
6. To provide proof of any current licenses and permits required to prepare, serve, and sell food & beverages with the State of Alabama.
7. To abide by current State of Alabama fire prevention guidelines.
8. There will be no refunds issued, under any circumstances.
9. The Scottsboro Three Arts Club is not responsible for the security of your belongings.
10. The Scottsboro Three Arts Club reserves the right to decline any food truck registration for Art Sunday at its discretion.

Food Truck/Vendor Registration Acceptance Policy:

Confirmation for Art Sunday is based on the date and time of application submissions AND payment. Additionally, we will take your menu into account when we receive your completed application. Our goal is to bring local food vendors/food trucks to the forefront to provide a unique experience for attendees by ensuring variety. While we are unable to guarantee there will not be competing vendors, we will take this into consideration as we receive vendor applications. The Scottsboro Three Arts Club reserves the right to turn down applications (and return fees) based on the number of applications received and overall variety of applications.

Proceeds:

Food trucks and vendors keep 100% of their proceeds for sales on the day of the event. However, food trucks/vendors are not allowed to sell ANY beverages at the event, unless approved by the Scottsboro Three Arts Club.

On-site Resources:

All food trucks and vendors must be able to operate independently of any provided resources at King Caldwell Park including water, electrical, refrigeration, and any materials.

Vendors are responsible for all set-up and clean-up of their booth space.
